Purpose of Role

Data Quality and Management

- Take a lead role in the development of a data warehouse to enable Beacon to be a data driven organisation.
- Achieve one version of the truth across all areas of Beacon, ensuring data integrity, accuracy, and consistency and identifying and resolving any gaps or quality issues.
- Lead and manage workstreams related to data quality.
- Supporting data governance and infrastructure initiatives, working and collaborating closely with the Tech Team to deliver these.
- Support the development of data standards, documentation, and best practices.

Data Analysis and Insight

- Conduct in-depth analysis of business data to identify trends, opportunities, and areas for improvement.
- Deliver actionable insights through data storytelling, helping service area leads, senior management and Board Members to understand key findings and use them to inform decision making.
- Develop and maintain interactive dashboards and reports using Power BI.
- Create automated reporting processes to improve efficiency and accessibility of insights.
- Ensure data visualisations are intuitive, engaging, and aligned with business needs.

Continuous Improvement and Innovation

- Contribute to the development and delivery of Beacon's Data Strategy, transforming how we use and manage data.
- Work closely with the Tech Team to identify opportunities for automation and process optimisation.
- Support the adoption of new analytics tools and methodologies to enhance data capabilities.

- Stay up to date with emerging trends in data analytics, machine learning, and AI.
- Participate in and ensure that the team participates in service interventions.
